THREE MEALS A DAY ARE SERVED EVERY DAY OF THE YEAR TO THE 72 MEN LIVING IN OUR SHELTER, PLUS SERVING ABOUT 20 MEALS A DAY TO INDIVIDUALS LIVING IN THE COMMUNITY. IN ADDITION, PROGRAMMING AND CASE MANAGEMENT ARE OFFERED TO ALL PARTICIPANTS LIVING IN THE SHELTER. THE MISSION MINISTERS TO OVER 2,200 HOMELESS AND POOR ANNUALLY, PROVIDING 26,200 NIGHTS OF SHELTER AND SERVING OVER 80,000 HOT MEALS EACH YEAR. COVID SIGNIFICANTLY REDUCED OUR NUMBERS DURING THIS FISCAL YEAR.
